Welcome to the Social Worker of the Year Awards 2021

We're thrilled to bring back the Awards to recognise outstanding and committed practice delivered by social workers during the past 18 months.

Against a background of societal and political upheaval, social workers continue to do as they have always done – create meaningful relationships so they can work collaboratively with people to achieve meaningful positive change in their lives.

This year we have pared down to 12 categories to better serve the online format. The nominations demonstrated the breadth and depth of the profession, the creative practice which has evolved in the face of challenges and the inspiration and difference social workers can make to individuals, their profession and wider society.

This year will be our first virtual awards ceremony, owing to the ongoing uncertainty around Covid-19. But we plan to bring all our 2021 and 2019 winners back together in person this coming March, for a special celebration at the Houses of Parliament. We can't wait to see you all in person again.

For those of you who are new to the Awards, we'd like you to know that they are run by an independent charity of the same name – the Social Work Awards Ltd – on a not-for-profit basis. The charity is run by a board of 12 Trustees who are, have been or are training to be social workers (from directors to students and everything in between) and people with lived experience. The money we raise from event sponsorship is used to pay for the full annual awards programme, including the Awards event and Parliamentary Reception.

The generous sponsorship we receive allows the Awards to thrive and reach more people than ever, share inspiring practice, and positively promote the profession nationally and locally in England. 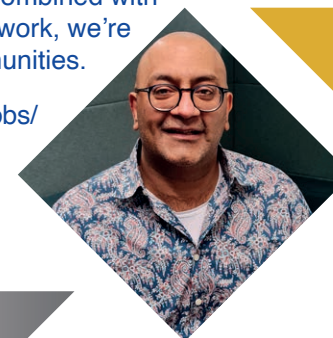
